Among those who were present and made addresses were Capt. Bradley of South Haven, Mich.; Lieut. J. K. P. Cottrell of Albany, and Lieut. W. P. Allen of Washington. Among those registered were: R. A. Soule, Mannsville; I. J. Rich, Fernwood; Dr. W. H. Cox, J. J. Hollis, M. Wilder, Sandy Creek; Chas. Myers, Pulaski.

Company D — Captain, H.C. Devendorf of Central Square; first lieutenant, D.D. McCoon of Phoenix; second lieutenant, W.S. Bradley of Phoenix.

Company E — Captain, John Sawyer of Mexico; first lieutenant, Samuel Nichols of Mexico; second lieutenant, William Smith of New Haven.

Company F — Captain, E. H. Boyd of Hannibal; first lieutenant, Isaac H. Peckham of Hannibal; second lieutenant, Thomas Hunter of Hannibal.

The 110th Regiment was stationed at Camp Patterson Park, Baltimore, Md., from September 5, 1862, until November 5, following, and on the latter date boarded the transport Erickson, on which they were forty-five days, enroute to New Orleans, La., forming a part of the expedition to render assistance to General Benjamin F. Butler.

Company B of the 110th Regiment was one of the companies which took part in the memorable charge of Port Hudson, La., June 14, 1862, and next June at the twenty-second annual gathering of the Reunion association of that company, which will be held in Pulaski, the fiftieth anniversary will be duly observed.

Company G — Captain, William P. McKinley of Oswego; first lieutenant, Ebenezer Jerett of Scriba; second lieutenant, A. B. Frey of Oswego.
